Individual Membership: \$175/annually

However, only one vote per Corporate membership will be valid.

MSRN Membership Requirements:

- a) Potential Members will be interviewed by a veteran member prior to continuing the membership process.
- b) A background check is required. Our background check process is at your expense (approx. \$60.00, but could be more depending on the states you have lived in). If you are able to furnish a recent background check (within the last 3 years), a new background check is not required.
- c) Potential Members are required to sign MSRN's Code of Conduct and to honor it as long as their membership is active. Read, Sign and attach to your application.
- d) Members are required to attend at least 8 events a year. Five of which need to be Member Meetings. Three (3) can be other events or you can attend 8 Member Meetings. Members who do not reach this requirement are not permitted to vote, and could lose their Good Standing status.
- e) All members are invited to attend all MSRN events.
- f) MSRN strongly encourages members to become active within our organization by joining a committee to help our organization continue to grow and be successful. And gives you the opportunity to get to know each other. We *require* you to sign up on a committee within the first 6 months of your membership.
- g) MSRN reserves the right to limit the number of members in each category. Currently two per category.
